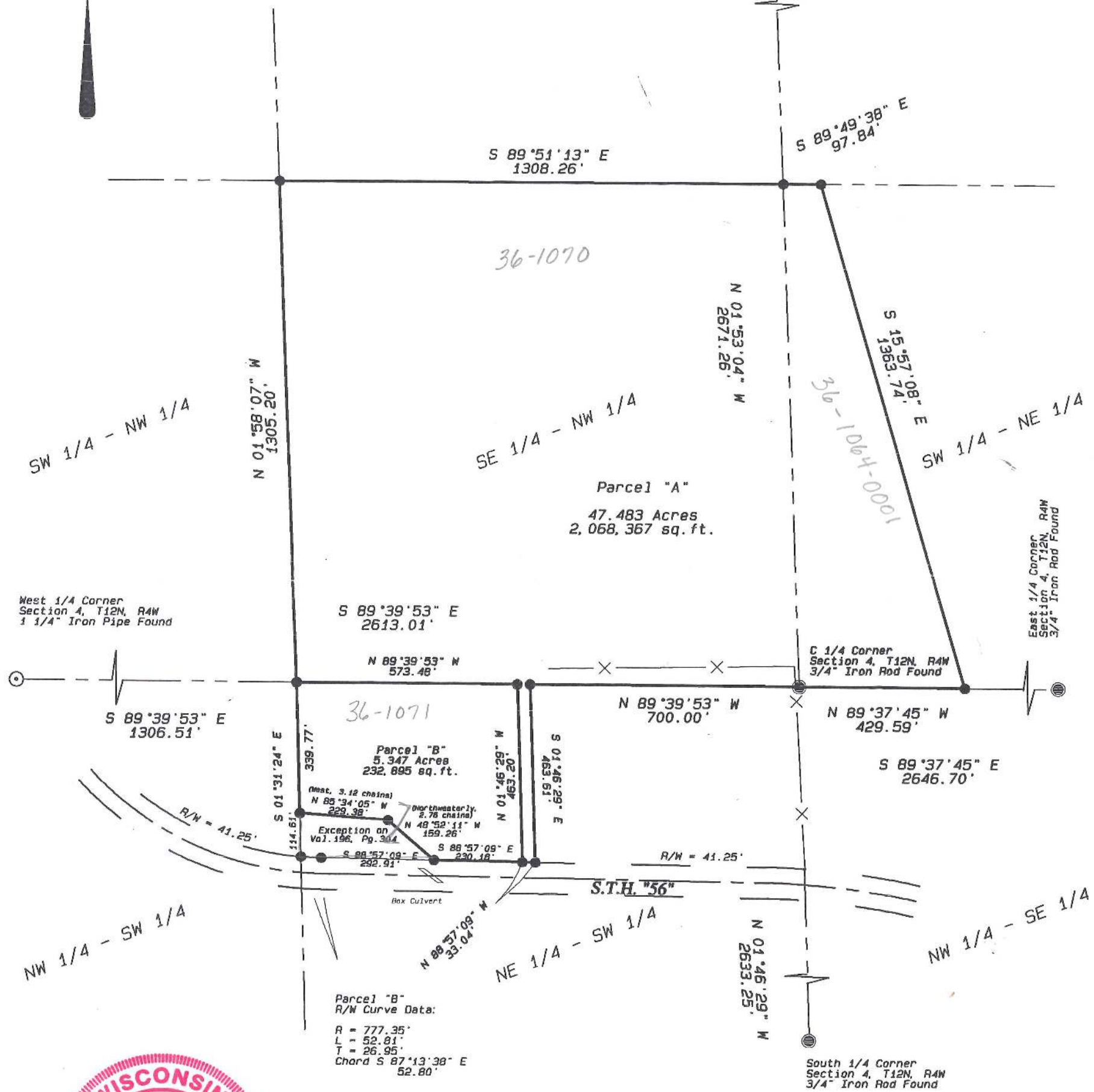
# Plat of Survey for Orbin Hanson

Description for Orbin Hanson:

Parcel "A"

Located in the Northeast Quarter of the Southwest Quarter and the Southeast Quarter of the Northwest Quarter and the Southwest Quarter of the Northeast Quarter of Section Four, Town Twelve North, Range Four West, Township of Viroqua, Vernon County, Wisconsin; bounded and described as follows:

Commencing at the West One-quarter corner of said Section 4; thence South 89°39'53" East, 1306.51 feet, along the North line of the Southwest Quarter, to the Southwest corner of said Southeast Quarter of the Northwest Quarter, and the point of beginning; thence North 01°58'07" West, 1305.20 feet, along the West line of said quarter-quarter, to the Northwest corner thereof; thence South 89°51'13" East, 1308.26 feet, along the North line of said quarter-quarter, to the Northeast corner thereof; thence South 89°49'38" East, 97.84 feet, along the North line of said Southwest Quarter of the Northeast Quarter; thence South 15°57'08" East, 1363.74 feet, to the South line of said quarter-quarter; thence North 89°37'45" West, 429.59 feet, along said South line, to the Southeast corner of said Southeast Quarter of the Northwest Quarter; thence North 89°39'53" West, 700.00 feet, along the South line of said quarter-quarter; thence South 01°46'29" East, 463.61 feet, to the Northerly right of way of State Trunk Highway "56"; thence North 88°57'09" West, 33.04 feet, along said right of way; thence North 01°46'29" West, 463.20 feet, to said South line; thence North 89°39'53" West, 573.48 feet, along said South line, to the point of beginning.

The above described parcel contains 47.483 acres or 2,068,367 square feet of land.

Parcel "B"

Commencing at the West One-quarter corner of said Section 4; thence South 89°39'53" East, 1306.51 feet, along the North line of the Southwest Quarter, to the Northwest corner of said Northeast Quarter of the Southwest Quarter, and the point of beginning; thence South 01°31'24" East, 339.77 feet, along the West line of said Northeast Quarter of the Southwest Quarter; thence South 85°34'05" East, 229.38 feet, recorded as East, 3.12 chains; thence South 48°52'11" East, 159.26 feet, recorded as Northwesterly 2.76 chains, to the Northerly right of way of State Trunk Highway "56"; thence S 88°57'09" East, 230.18 feet, along said right of way; thence North 01°46'29" West, 463.20 feet, to the North line of the Southwest Quarter; thence North 89°39'53" West, 573.48 feet, along said North line, to the point of beginning.

The above described parcel contains 5.347 acres or 232,895 square feet of land.
